EXECUTIVE SUMMARY

Background

The U.S. Department of Housing and Urban Development (HUD) requires all entitlement communities receiving Community Development Block Grant (CDBG) funds, such as the City of Hesperia, to prepare and submit a Consolidated Plan every five (5) years to establish a unified, strategic vision for economic development, housing and community development actions. The Consolidated Plan encompasses the analysis of local community needs and coordinates appropriate responses to those needs and priorities.

The Consolidated Plan is carried out through Annual Action Plans which provide a concise summary of the actions, activities, and the specific federal and non-federal resources that will be used each year to address the priority needs and specific goals identified in the Consolidated Plan.

In addition, in 2008, the City received funds under the Neighborhood Stabilization Program (NSP) which Congress created to counteract the negative consequences of the foreclosure crisis brought about by the housing market collapse. Since its inception, the City has since expended all its NSP grant funds and anticipates closing out the program during the 2022-2023 program year. As part of the NSP closeout process, the City is allowed to transfer program income generated under the program, over to the CDBG program to be repurposed for CDBG eligible activities.

Per the City's Citizen Participation Plan (CPP), a Substantial Amendment to a Consolidated Plan and Action Plan is required when a "substantial" change is proposed as it relates to funding priorities, proposed activities, goals and objectives. This substantial amendment to the Action Plan is necessary because the City is proposing to a) repurpose \$211,103 in prior year uncommitted CDBG funds, and b) transfer \$3,535,941 of NSP program income to the City's existing 2021-2022 Street Improvement Project.

PROCESS

The City is conducting a 30-day public review period for this substantial amendment from October 14, 2022, through November 15, 2022. The City will conduct a public hearing for the substantial amendment as part of the November 15, 2022, City Council meeting.

To encourage review and comment on the proposed activities, the City published notices in English and Spanish in the Hesperia Resorter on Thursday, October 13, 2022, the City's website and social media accounts, advertising the substantial amendment in compliance with the City's Citizen Participation Plan. An electronic copy of the substantial amendment is available on the City's website and hard copies were made available at the City Economic Development Department, the City Clerk's Office, and the Hesperia Public Library.

To ensure reasonable participation in the public hearing, residents may attend the public hearing in person at the City Council Chambers located 9700 Seventh Avenue, Hesperia, Ca 92345 or can watch it live streamed on the City's website. Public comments can be made in-person at City Council Meetings and/or via telephone by calling ahead of time and recording a message with the City Clerk's office at (760) 947-1056.
