12. Substantial Amendment to the Community Development Block Grant (CDBG) 2021-2022 and 2022-2023 Annual Action Plans

Recommended Actions:

It is recommended that the City Council: (1) conduct a public hearing and upon accepting public testimony, adopt Resolution No. 2022-76 including any modifications or amendments thereto (2) approve a Substantial Amendment to the Community Development Block Grant ("CDBG") 2021-2022 and 2022-2023 Annual Action Plans ("Action Plans") by repurposing a total of \$3,747,044 from prior year unprogrammed CDBG funds and program income from the Neighborhood Stabilization Program (NSP) to the 2021-2022 Street Improvement Project; (3) authorize staff to appropriate prior year unprogrammed CDBG funds and NSP program income for the 2021-2022 Street Improvement Project; and (4) authorize the City Manager and/or Designee to execute and transmit all necessary documents, including the Substantial Amendment to the Action Plans, and any additional amendments, to assure the City's timely expenditure of CDBG funds.
